Members of Grace,

I have updates on three topics to share with you this month. As always, members of our Council are willing to answer any questions you may have. I can't ask anyone to hug a Council Member at this time but I can tell you that we should all be thankful for this group of folks that has spent so much time in thought, prayer, and discussion to make decisions for our church during this difficult period.

The first update is on our heating and cooling project. To start, I am happy to report that the vote was 62-1 in favor of installing the commercial product. This is great for two reasons. First, we had at least 63 people come in-person for the vote and Communion distribution. That is an amazing display of dedication to our church! Second, it is great that the judgment of the Trustees has been validated by the result of the vote. When the project is complete, our church will be more comfortable and will be cheaper to heat and cool. Also, the commercial equipment being installed has fewer moving parts than the old system and should be easier to maintain. The project is tentatively scheduled to start the beginning of October and should take 2-3 weeks...as long as the equipment is delivered as promised.

The second update is regarding Stewardship. This is traditionally the time of year that we talk about Stewardship and are scheduling a potluck. Well, the potluck is out but we can still talk Stewardship. It is extremely important that we don't fall out of the habit of giving. I know that expenses are lower than normal right now but they will go back up when we get a full-time pastor. I encourage you to look at your giving record when you receive it and resolve to do any catch up giving in the 4th quarter as you are able. Also, Love Offering envelopes are enclosed with the Scroll this month if you would like to give a special gift. Keep in mind that Stewardship is not just about the giving of money. Stewardship is also about giving time and appreciating our many blessings. Please take some time to think about the many wonderful things that are happening at our church right now and say a prayer of thanksgiving for the people making those things happen.

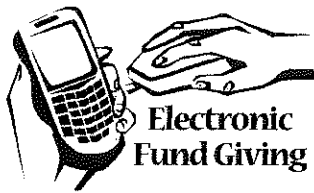

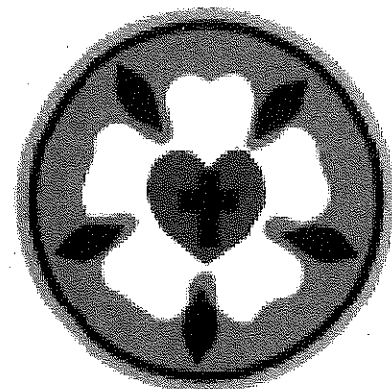

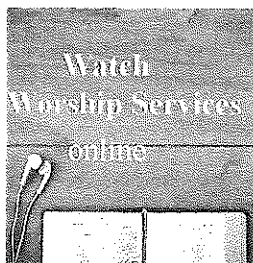

FROM THE COUNCIL, con't.

The final update for this month concerns reopening the sanctuary for worship. You will see in the September Council minutes that a discussion was held on this topic. The numbers on infection rates, etc. and progress on an effective vaccine suggest that there will be an elevated risk for COVID infections for some time to come. As the sanctuary cannot remain closed forever, the Council has agreed to prepare for opening on a limited basis at some point in the future. I want to stress the word limited if we open up anytime soon. We understand the strong desire of some among us to worship in our church. We also understand that many among us are at a higher risk of serious complications if infected with COVID-19. Therefore, we will be adding worship in the sanctuary as an option, just like GVTV, Facebook, and YouTube. We will do our best to ensure no one feels bad or left out by choosing any particular option for worship. We will need volunteers to add to the in-person option for worship. If you are interested in helping make worship in the sanctuary happen, please contact Kim in the office. As for the other options, I am happy to report that we are exploring a project with Garden Valley that will allow us to stream worship live to the TV while continuing to provide the Facebook and YouTube choices. More on that is to come.

Call to Order: President Jason called the meeting to order.

Devotions: Jason gave the devotion. "Lead Like Jesus"—subject of the devotion was leadership. Our leadership is entrusted to us by the Lord. (Based on Genesis 2:15) We need to remember that we are here to serve, even when the decisions are difficult.

Approve Agenda: Motion to approve the amended agenda as presented by Gary. Seconded by Wade. Motion carried.

Secretary's Report: Lori moved to approve the minutes. Seconded by Yvonne. Motion carried.

Financial Secretary's Report: Ann moved to approve. Seconded by Hollie. Motion carried. (Report on file).

Jim and Dorothy met to correct the problem of the income from our credit card offering. It had previously not shown in Doro-

thy's report so now Jim and Dorothy's revenue's match.

Treasurer's Report:

Cash Flow Report

- Undesignated funds available to be used for August's General Fund expenses totaled \$9,341.48. This amount exceeded the month's General Fund expenses totaling \$9,032.75.
- Congregational giving to the General Fund was \$9,306.53. The monthly budget goal is \$17,957.40.
- Noteworthy Other Giving –
 - o Oil Leases – Both payments were received in August. First time in several months.

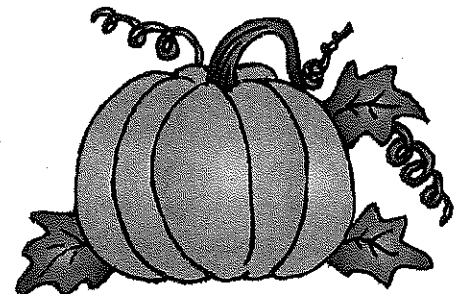

All of the major budgeted expense categories ended under budget for the month.

History of Regular Giving to the General Fund Report

- August's giving was up for the first time since March 2020!
- However, it is the second lowest giving so far in 2020.
- This was the second lowest giving for an August in 10 years.

This was the lowest giving year to date since 2011.

History of the General Fund Balance

- Highest balance ever!!

Balance continues to increase due to decreased monthly expenses.

Account Balances Report

- Building Fund - Reflects the monthly expense for the separate elevator phone line.
- HS Scholarship Fund – Reflects a donation.
- Oil Fund – Bldg Upkeep reflects a portion of this month's oil/gas revenue.
- Oil Fund – Church Emergencies reflects a portion of this month's oil/gas revenue.
- Oil Fund - Missions reflects a portion of this month's oil/gas revenue.
- SS Offering Outreach Fund - Reflects the monthly donation of \$38 to Compassion Interna-

al.

- Stained Glass Window – Paid off the balance owed on the new stained glass windows in the narthex.

VBS Fund – Various expenses related to VBS.

Brovold Investment Valuation Report

- The ending balance had a slight increase over last month.

This is the highest balance since January 2020.

Gunderson Investment Valuation Report

- The ending balance had a slight increase over last month.

It is the highest balance ever.

Other Information

Per President Carlson, Andrew has requested to be compensated again beginning in September.

Ameriprise Financial's representative, Ashley Bergman, plans to be here for our next meeting. Be thinking of questions regarding the Brovold Estate. We, as a church, are going to need to consider an investment policy. At the very least we need a set plan to review our investments. We also need to look into creating a gift acceptance policy.

Nick made motion to approve. Gene seconded. Motion carried.

Pastor Report:

Jason talked to pastor recently. At this point, Pastor Mike is happy to maintain the status quo.

Committee Reports:

Stewardship: Lori reported. Love Offering will happen. The Love envelopes will come out in the Scroll. Dorothy will send out the statements reporting current giving balances. We will signify that October will be Love Offering month and encourage people to prayerfully consider their giving and return their Love envelopes. Rally Sunday will be on hold until we open the sanctuary.

Education: Ann reported. We have 63 students in our Sunday School who are fairly regular attendees. We are ready to deliver the distance curriculum. We currently have 21 students signed up to attend Sunday School by distance. The procedure to deliver SS will be evaluated on a month-to-month basis. We so appreciate all the work that Ann has done. Parents can also pick up hard-copy Sunday School lessons at church if they would rather have SS using this method. Ann is still short some teachers. We have enough teachers to start on-line SS, but more will be needed when we start face-to-face. We will not burden the school by asking about Released Time at this point. We will revisit this when there is more information regarding the school's outcomes after being in session. Calendar is set up for the entire year regardless of the method of delivery of the SS curriculum.

Youth Group: Jim and Hollie reported. The "Feed My Starving Children" event is going to be

happening Halloween (2 days) in Grand Forks. At this point we do not plan to attend due to Covid 19. We have donated financially at this point, however, attending doesn't seem like a responsible decision at this time.

NALCW: Hollie reported.

NALCW will be rescheduled until next Thursday. The 80 year olds will be recognized by receiving devotion awards for all who turned eighty in 2020. All the quilts are ready to go to Detroit Lakes and will be delivered this week. Hollie's daughter will deliver them for us. We thank her for that service. Elections will be held in November.

Trustees: Wade reported. Wade called Al's Electric about the upstairs lighting issue that hasn't been corrected yet. Al has not responded. Wade will check again with him. We also have some issues with the previous upgrade to our lights that was done by No Boundaries. Wade will be checking into this and contacting them. Ryan Schow called to report that a new boiler would be about 3 weeks out if the vote passes. Work on other parts of the project can begin prior to the arrival of the boiler. Front door in the Sunday School section has no panic bar. This is a serious issue and will need to be addressed as soon as possible. We will contact Fargo Paint and Glass, or Sterling in Grand Forks to check on purchasing one. We will ask Jeff Nornes for advice regarding suggestions for who

could be hired for installation. When Food Shelf is open, they will need to have one of the other doors open to provide for a safe escape if needed. Maintenance is still an issue with the building. The job description must be completed and we must have the discussion regarding expectations for the upkeep of our building. If we need additional hours to complete the tasks we deem necessary, we do need to realize that we will need to pay for those hours. We must make a commitment to deal with these issues. As a Council, we need to get together to create a checklist with weekly and monthly tasks that meet the congregation's expectations. Hollie will talk to the NALCW to ask for suggestions regarding any expectations they need included on a checklist. Mary volunteered to help in creating an expectation list. The question was raised asking if we had ever considered hiring a cleaning service? Wade will check into this. He will see if we can get a company to come and give us a cost estimate. Wade will let Jason know when he gets the info.

Deacons—Mary and Gene reported. Didn't formally meet. They have been working with pastor to coordinate worship.

Call Committee: Nick reported. One interview has been completed with a possible candidate. The committee has received a recorded sermon from the candidate. All references have been contacted at this point.

The committee is meeting tomorrow night for further discussion.

Food Shelf-Gene reported

Total pounds last month 2,744 which was a new record. Served 27 families averaging 101 pounds per family. Pounds per person was 48. Farmers to Families CFAP Food Box Distribution will be Monday (8/24/20) at the school. Distribution starts at 9:00 a.m. They will plan for 60 people. Food Shelf grant is used up. They are trying for another grant for \$2500. If they get the grant they will be fine financially. If not, they will have to advertise for donations. Food Shelf needs another freezer (which is not available now). They are currently using a freezer at the grocery store. With the installation of a new heating system there may be room freed up in the church to house an additional freezer. The preference by all would be to not use the garage behind the parsonage.

More volunteers are always needed. Please consider this service and let them know if you would be available.

Old Business: Worship in Sanctuary (Jason)

Things are not looking up in reference to the Covid situation. We really need to watch the reports for our area. There is a lot of worriment regarding Covid, plus the fact that the regular cold and flu season is coming. This makes the Council's decision very difficult. A reopening does not only affect

our worshipers, but involves all the people necessary for the implementation of a successful service and the critical sanitation needs for that service.

The Council feels that we need to monitor how the school's numbers line up and what results from their face-to-face and hybrid opening plan. We need to get an implementation plan ready now so that whenever the opening date is set we are prepared. Volunteers will be needed for worship aids. We need to find out if we have willing people, and we have to let them know the expectations and responsibilities. Jason will do a communication to the congregation asking for volunteers. The communication must also include information informing our congregation that upon reopening worship will, and has to, look different. We understand people's need to come back to church, however it must be done as safely as possible. We will prepare to reopen, but we can't set a date at this time. Jason asks us to be thinking about our needs for reopening, and to please communicate those needs with him. Jason has received some reopening plans to review and that could be used to assist in the creation of our own plan.

Nick reported on the equipment needs for the video production of our church services. He has a quote from GV for a complete video and production system. (\$25,620). This quote includes equipment that is basically the

same system that Hope Church in Fosston uses. Successful use of the system will require training. Once training is accomplished and the system is set up, it should be easy to use and provide for a professional product. This system quote includes everything needed to produce a video production. The new system will give us the ability to stream live to GV. We also want to send to live stream to Facebook and Youtube. Ability to record for later playback done by GV. We want to have picture on picture ability. (Example: If there's a slide show being shown in the service we would want to see the slide show in the corner of the screen while also seeing the regular picture. Possible placement for the equipment would be in the back of sanctuary (1/2 of the last pew in the middle section). Nick like's this location due to easier access to electrical connectivity, as well as less disturbance of the traffic flow. Another option would be the back corner by the coat rack. This location would be more difficult for running cable and electrical connections. Discussion also was for upstairs where it would be close to the camera. No decision has been made. Nick would like at least 5 volunteers to be trained on the system. We will probably need a coordinator to monitor the volunteers.

As a Council, we truly feel that this improvement in equipment follows our mission to serve our Lord. The budget, through gifts, would cover our cost. We know

that we have gifts designated for the building. Gifts can be used at the discretion of the Council. We do have the money to cover this. We would not need a congregational vote for this expenditure. Nick will have more meetings with GV to get more information and to learn as much about this equipment as he possibly can. We thank Nick for the many hours he has dedicated to this research, and his dedication to "making things work" with the equipment we have, and what he's been able to scrape together throughout this Covid situation.

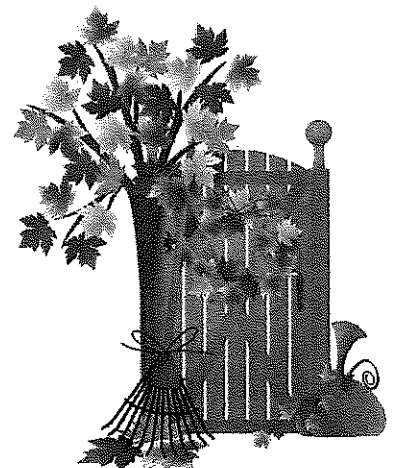

How Will COVID-19 Impact Children in Poverty?

We're all feeling the weight of COVID-19. But in the communities where Compassion works, things are becoming desperate. Although children seem to have less severe symptoms from COVID-19, the long-term ripple effects of the pandemic could be devastating for the world's children.

Today I want to talk to you about something that may be hard and that we may want to look away from. But at Compassion, we know that we can't look away from the hard things that impact the world's children.

How is the coronavirus affecting Compassion and the children we serve?

Although medical professionals are reporting that COVID-19 has a lower mortality rate for the young, with a pandemic of this size, it will inevitably take some of the youngest from us. And for children living in communities with less developed healthcare systems, they will be even more vulnerable to the disease. But beyond the heartbreaking number of lives that will be lost due to contracting the disease, we know

that the long-term impact on children in poverty could be dire. Children, and particularly children in poverty, seem to always bear the worst burdens during global crises. Here are a few of the ways we anticipate this situation affecting children.

How will COVID-19 affect education for children in poverty?

More than 1.5 billion children and youths are out of school. Many of the world's poorest children have no access to the internet at home or electronic devices with which to engage in online learning. These are the same children who already have lowered outcomes in school because of the impacts of poverty: school interruptions due to an inability to pay fees, difficulty focusing on schoolwork because of labor activities, etc. In short, COVID-19 could put those who are the most disadvantaged even further behind in school.

How will COVID-19 affect child labor?

Child labor around the world has been steadily decreasing with rising incomes. However, as unemployment rises, child labor may as well, as children are forced to help their parents feed the family. If children are orphaned or become the heads of household, they may have to

drop out of school to provide for themselves and their siblings.

How will COVID-19 impact child abuse?

Tragically, around the world countries are seeing indications that domestic violence is rising during this crisis. In some countries, calls to helplines are up, while on the other hand, reporting of child abuse may be down with children out of school. Some experts believe that the pandemic might result in an increase in child marriage as families move below the poverty line due to income loss. Europol is also reporting that criminals are using the pandemic to exploit children online. And if more children become orphaned, their vulnerability to trafficking and other forms of exploitation will rise.

How will COVID-19 impact other health issues?

If healthcare systems become overwhelmed or children have less access to healthcare centers, this can increase the number of deaths from other causes such as malaria, tuberculosis and HIV/AIDS. For example, in West Africa, deaths from these causes spiked after the Ebola outbreak in 2014 and 2015. In some countries, vaccination campaigns have also ceased.

How will COVID-19 impact malnutrition and child deaths?

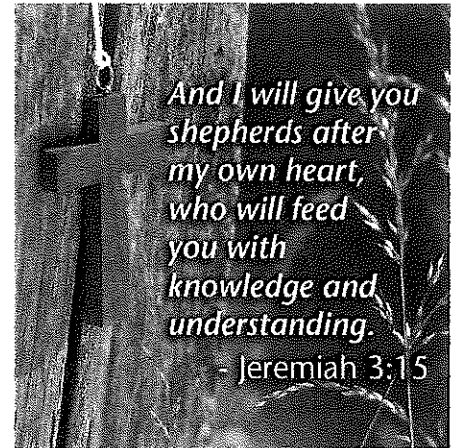
Many children around the world rely on school meals for daily nutrition. With this vital source of food removed for many children and parents unable to work, malnutrition and stunting could increase. In fact, U.N. Secretary-General António Guterres warns: Let us speak out on behalf of these children. Scriptures command us to speak up for those who cannot speak for themselves and to advocate for the rights of all those who are destitute (Proverbs 31:8).

There can be no greater cause than to advocate for the needs of children, particularly those who are vulnerable. Each one of us can and should act. Let us rise up as the Church to help the most vulnerable. We believe the Church is the way God wants to touch this hurting world. That's why at Compassion we partner with the local church to bring care to the most vulnerable children in the world. "With the global recession gathering pace, there could be hundreds of thousands of additional child deaths in 2020. We believe God is inspiring his Church to rise up. To be the light-bearers in this dark time. To offer physical, emotional and spiritual support to chil-

dren in need. Indeed, the need for Compassion's ministry will only increase dramatically as the full impact of COVID-19 becomes clear.

We ask, I ask, that you rise up as one with the Church. If you are still in a position where you are able to, please give to help children who will become even more vulnerable to the devastating effects of poverty. Help the church around the world ensure they are safe, fed, loved, known and protected. Help a Vulnerable Child Today!

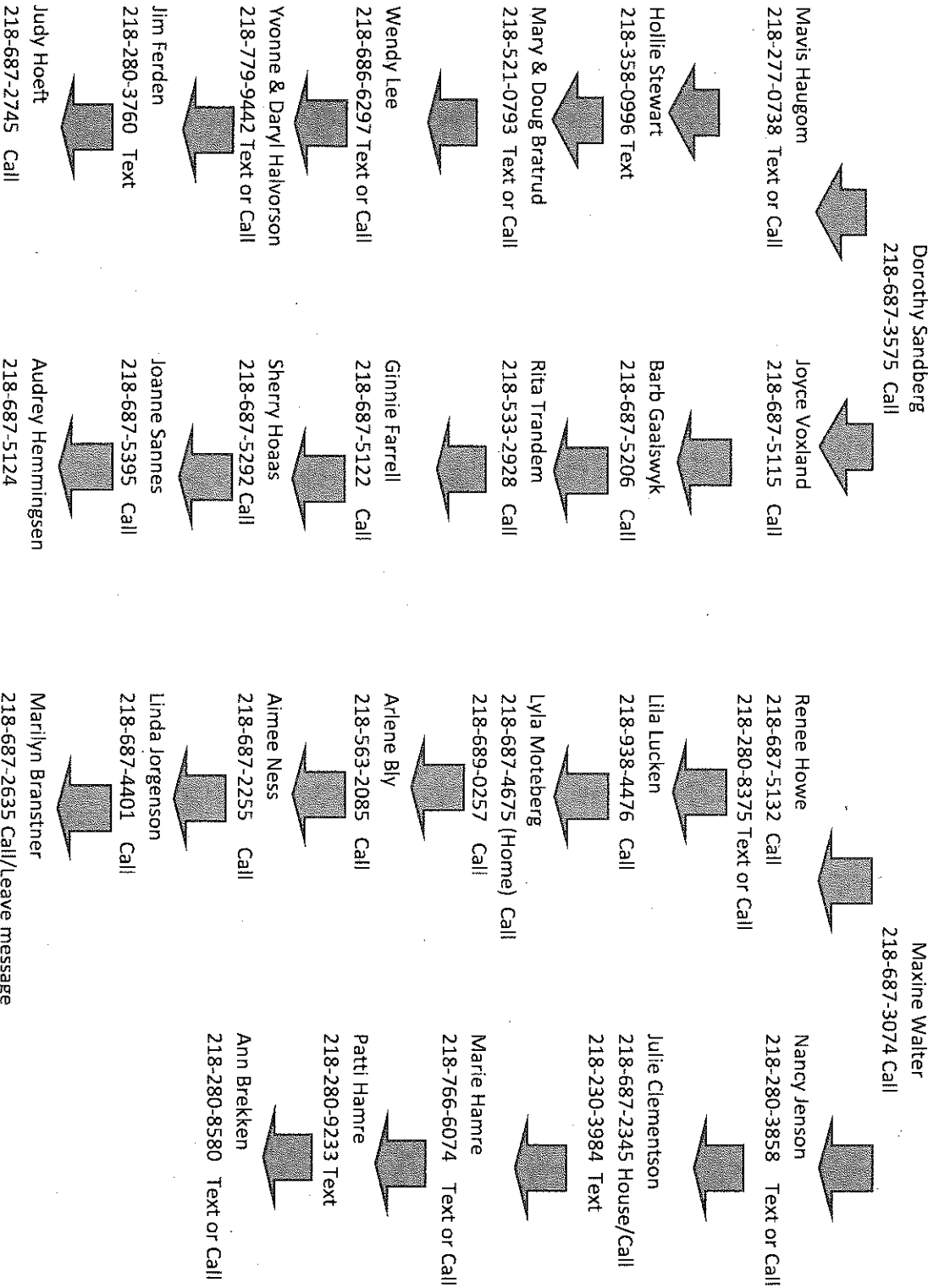


Prayer chain
